Scholarship Application – 2020-2021**

The NANA Worley Scholarship Program has been organized under Section 29 of the Grant of Right of Way Agreement Lease for the operation of the Trans-Alaska Pipeline. The goal of the Scholarship Program is to provide financial aid to Alaska Native students, which will assist them in achieving their college educational goals and prepare them for jobs on the Trans Alaska Pipeline System (TAPS).

Number of Awards:

The number and amount of scholarships/grants awarded each year is dependent upon:

- The number of eligible applicants
- The quality of applications
- The availability of funds

Applicants Must Meet the Following Eligibility Requirements:

- Applicants must be of Alaska Native heritage and be able to provide acceptable documentation (see the checklist for specific documentation accepted).
- Drafting & Design - Have a high school diploma or equivalent. Be enrolled in a drafting certification program or enrolled in an associated technical degree program.
- Engineering – Must be enrolled in an engineering degree program and hold a 2.5 or higher GPA.
- Business/Finance – Must be enrolled in a business degree program and hold a 2.5 or higher GPA.
- Internships - Have a high school diploma or equivalent. Be enrolled in a drafting certification program, an associated technical degree program or enrolled in an engineering or Business degree program.
- Be enrolled in an accredited undergraduate or graduate program at a college or university, which will prepare candidates for a position on the Trans-Alaska Pipeline or AutoCAD/Drafting or related field.
- Be a full-time (12 credit hours or the number of credits the school requires for full-time status) student during the entire academic year to be eligible for the total scholarship amount offered.
- Scholarships are available for part time students and awards are pro-rated to the number of hours less than full time.

Award Criteria:

- The primary emphasis of NANA Worley Scholarship Program is to provide educational assistance and Internships to Alaska Native Students pursuing degrees in the Engineering, Design and Drafting fields which correspond to the services that NANA Worley provides Alyeska under contract. While applicants in other educational fields will be considered, preference is made towards the Engineering fields.
- All scholarships are awarded on a semester/term basis.
- Be enrolled as an undergraduate or graduate student pursuing a drafting certificate program or four year degree at an accredited institution and maintain at least a 2.5 GPA during the scholarship year.
- All scholarship award payments are issued in the college's name and sent to the financial aid office address stated on the awardee's application.

How to Apply:

If you are interested in applying for a scholarship, you must meet the above eligibility requirements and complete the attached application.

Application Deadline for Summer 2020 is June 22, 2020, Fall 2020 is August 1, 2020 and Spring is January 10, 2021 at 5:00PM (AKST). This is a firm deadline. No exceptions are allowed.

Drafting & Design/ Engineering/Business/Finance – CERTIFICATE/COLLEGE STUDENT CHECK LIST

This also includes anyone applying for Alaska Native Program/NANA Worley Alaska’s scholarship for the first time.

- ❑ Completed application. Incomplete applications will be returned. **(NO EXCEPTIONS)**
- ❑ **“Official”** College/University transcripts – only if you are applying for the Alaska Native Program Scholarship for the first time and you are currently attending a University or college.
- ❑ Copy of current class registration indicating full-time status
- ❑ Copy of **“Official”** Letter of acceptance from your vocational or college/university
- ❑ Statement of Purpose (300 words) - This essay must provide introductory information about the student, detail the student’s education and career goals (both short and long term), expected graduation date, and how their selected academic career will link directly to a position on the Trans-Alaska Pipeline. This essay must accompany the application. There are no exceptions.
- ❑ Current Resume
- ❑ Provide **ONLY ONE (1)** of the following documents indicating Alaska Native Heritage. The following are the various examples of documents that you can submit to complete your application.
 - CIB Card (Certificate of Indian Blood)
 - BIA Card (Bureau of Indian Affairs)
 - Tribal enrollment Number (this must be an “official” letter from your regional corporation or your parent’s regional corporation)
 - Alaska Native Claims Settlement enrollment number

The Deadlines are Summer 2020 is June 22, 2020, Fall 2020 is August 1, 2020 and Spring is January 10, 2021 at 5:00PM (AKST): **No exceptions to the deadline.**

The goal of the Alaska Native Education Award is to provide monetary support for Alaska Natives to acquire education and/or training needed to prepare for jobs with Alyeska and its contractors on the Trans Alaska Pipeline System (TAPS). Applicants must be of Alaska Native heritage.
